- 1. Plans and facilitates meetings
- 2. Creates annual summary of activities
- 3. Responsible for communication with School Council and messaging for school newsletter

Vice Chairperson – currently Kayla Webb

- 1. Assists chairperson, assumes their duties if in absence
- 2. PIPA/privacy officer

Secretary – currently Andrea Merino

- 1. Takes minutes and attendance at meetings
- 2. Ensures all minutes and documents are available to the public

Treasurer – currently Janine Waldo

- 1. Maintains records of all financial transactions
- 2. Reports financial information to the School Council

The executive committee runs the day-to-day operations of the society and serves a term of one year, to be elected at the AGM.
